DECLARATION OF PENSIONABLE INCOME – NOTES to Part 7 – Ministers Section

ITEM

1 & 3a The minimum full time pensionable income for 2013 is £26,700 which includes the Home Mission Stipend of £20,700 plus £6,000 in respect of the value attributable to a manse provided rent and council tax free.

3b LEASE OF A MINISTER-OWNED PROPERTY If the minister provides their own accommodation and payment is made to them by the church under a formal agreement, then, under Revenue regulations, the amount paid cannot be included as part of their pensionable income. In this instance the nominal manse value should be entered under item 3b of the declaration form and no further entries under any of the item 3c headings.

- 3c i If accommodation is owned partly by the minister, please state the percentage interest owned by the church and ENTER THAT PERCENTAGE OF £6,000 IN THE COLUMN.
- 3c ii Where a rental or housing allowance is paid by the church in respect of the proportion of the property owned by the minister, enter the sum expected to be paid during 2013.
- 3c iii Enter the amounts received from or paid by the church in respect of the proportion of the property owned by the minister. These figures may be the amounts paid in 2012 or the estimated amounts payable in 2013.
- 3d Although a minister-in-training on the In-Pastorate Training Scheme normally receives half stipend, the minister-in-training may live in a manse on a full time basis. It has been decided that a minister-in-training may add the value of the manse to calculate pensionable income as follows:
 - 100% of the manse value for pension purposes
 - or
- 50% of the manse value for pension purposes
- or
- a proportion between 50% and 100% of the manse value for pension purposes

For a part-time minister, if less than 100% of the manse value is being added to calculate pensionable income, for instance if the manse is occupied by two part-time ministers, enter the percentage of full-time hours worked.

NB Contributors and churches are reminded that the value attributable to a manse provided rent and council tax free is reviewed from time to time.
